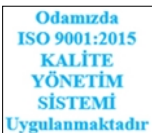
Yazıda, söz konusu bölgede bulunan Lotus Tipi Endüstriyel Üretim Özel Ekonomik Bölgesi (SEZ Lotus) ve Liman Özel Ekonomik Bölgesi'nin (Port SEZ), RF Hükümeti'nin 18 Kasım 2014 tarih ve 1214 sayılı Kararnamesi uyarınca kurulmuş olduğu ve söz konusu bölgelerde halihazırda 16 kiracı firmanın faaliyet gösterdiği ifade edilmekte olup, mühendislik altyapısı, yollar ve bölge gelişimi ile ilgili çalışmaların devam ettiği bildirilmektedir.

Yazıda devamla, Astrakhan Bölgesi'nin, Rusya'da, Hazar Denizi, Hindistan, Güneydoğu Asya ve Orta Doğu ülkelerinin pazarlarına erişimi olan tek özel ekonomik bölge haline getirilmesinin planlandığı belirtilmekte olup, INSTC'nin söz konusu bölgelerden Avrupa'ya nakliyatın gerçekleştirilmesi anlamında, en kısa ve ekonomik rota olduğu, örneğin Süveyş Kanalı'ndan geçen rotaya göre, yarıdan fazla zaman ile, %30 oranında maliyet tasarrufu sağladığı belirtilmektedir. Ayrıca, Özel Ekonomik Bölgeleri'nin kiracılarına, vergi ve gümrük imtiyazları (Rusya Federasyonu yasalarına göre), kamu hizmeti altyapısına ücretsiz bağlantı, ticari faaliyetlerde idari engelleri aşan bir "tek durak noktası" sistemi, güçlü lojistik olanakları (demiryolu, karayolu ve gemi taşımacılığı), tercihli arsa kiralama koşulları, arsa üzerindeki gayrimenkul inşaatı tamamlandıktan sonra arsa satın alma imkanı sağladığı bildirilmektedir.

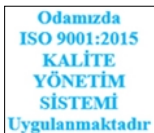

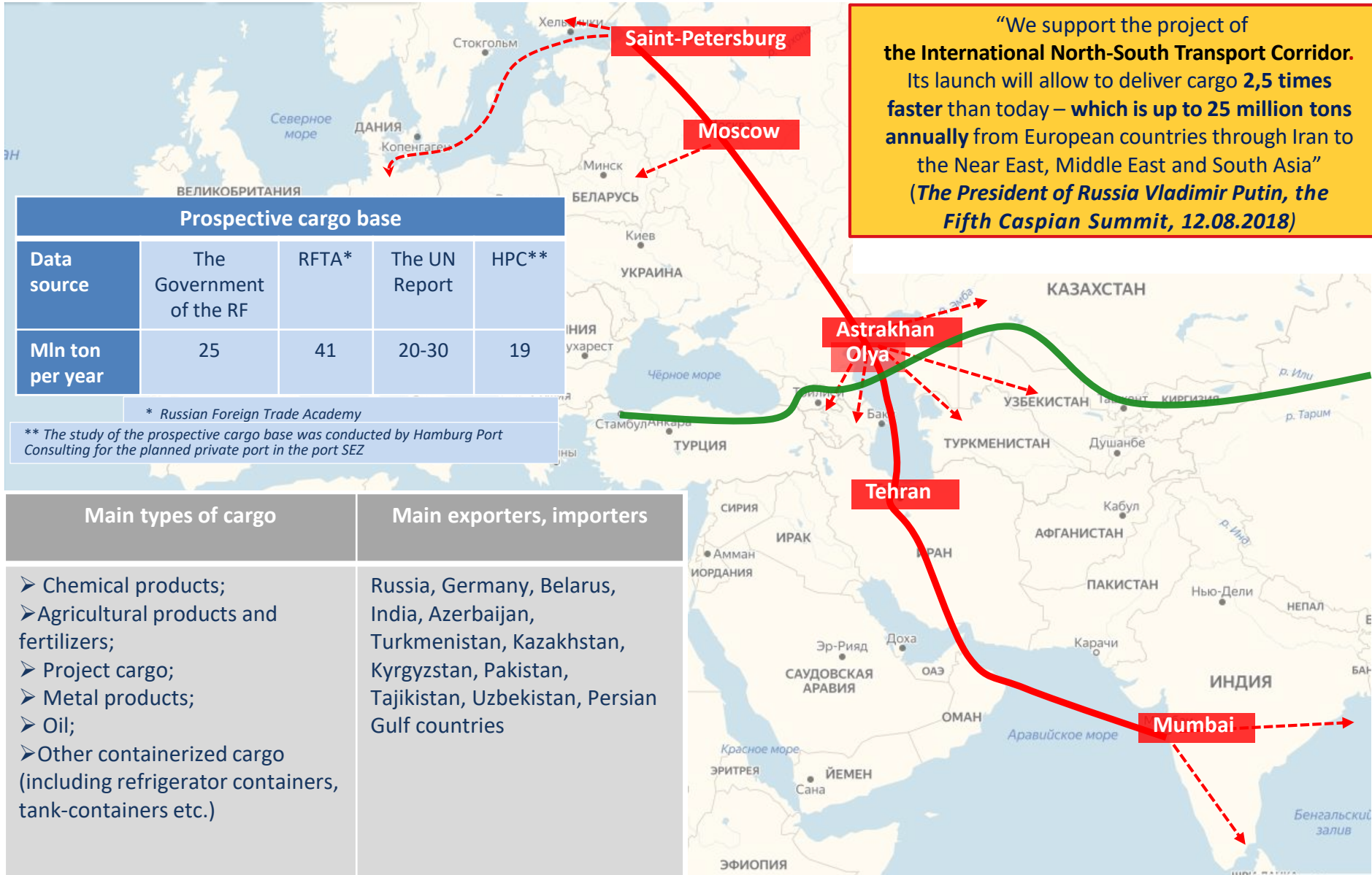

A PORT SPECIAL ECONOMIC ZONE TENANT HAS THE RIGHT TO CARRY OUT **PORT ACTIVITIES AND (OR) CONSTRUCTION, RECONSTRUCTION AND OPERATION OF PORT INFRASTRUCTURE FACILITIES**

The port activity is the following activity performed in a port:

- ⦿ goods warehousing, storage and other service typically rendered in a sea port, river port, airport according to the international contracts of the Russian Federation and the Russian Federation legislation;
- ⦿ provision (including with marine stores, board supplies) and equipment of vessels, aircraft;
- ⦿ production, repair, maintenance, modernization of sea-going, river and aircraft, aerotechnics, including aviation engines and other components;
- ⦿ water biological resources processing;
- ⦿ preparation operations of goods for sale and transportation (packing, sorting, repacking, lot dividing, marking and similar operations);
- ⦿ simple assembly and other operations, execution of which does not considerably change goods condition according to the list approved by the Russian Federation Government;

- ⦿ provision of port special economic zone infrastructure facilities functioning;
- ⦿ production activity according to the port special economic zone activity agreement.

Special economic zone of industrial production type Lotus (SEZ Lotus) and a port special economic zone (port SEZ)

SEZ Lotus and a port SEZ are located in the Astrakhan region at the intersection of the International North-South Transport Corridor (the INSTC) and the north part of the Great Silk Way. The Astrakhan region has borders with the countries of the Caspian Sea. There are 8 states within a radius of 1000 km from the Astrakhan region with a total population of more than 300 million people.

Such advantageous geopolitical location of SEZ Lotus and a port SEZ makes them the only special economic zones in Russia that have access to the markets of the countries of the Caspian Sea, India, the countries of Southeast Asia and the Middle East. Under the conditions of an active development of the International North-South Transport Corridor, implementation of a project on the territory of special economic zone in the Astrakhan region is the best solution for a company, planning to enter this market.

The INSTC that runs through the Caspian Sea and the Astrakhan region, is the shortest and the most cost-effective route for cargo deliveries from India, Southeast Asia, Africa and Middle Eastern countries to Europe and back. The main advantages of the INSTC compared to other routes, in particular over the route running through the Suez Canal, are distance reduction by more than half, time saving for container cargos transportation from 37 to 15-17 days, and 30% reduction of transportation costs.

Industrial production special economic zone Lotus (SEZ Lotus) was established in the Astrakhan region according to the Decree of the Government of the Russian Federation №1214 of November 18, 2014. Currently, in SEZ Lotus there are 16 tenants with more than 30 billion rubles of the declared investments, including companies from Russia, Italy, Azerbaijan and Iran. Tenants are provided with engineering infrastructure, the roads are being built, development of the territory continues.

According to the set of measures for the development of the INSTC transit potential on November 7, 2020 the Decree of the Government of the Russian Federation on the creation of a port special economic zone in the Astrakhan region, which will be united with the industrial-production SEZ Lotus into the Caspian Cluster, was launched. Construction of a new port and logistics complex with a modern container terminal will be the anchor project.

SEZ Lotus tenants can carry out various types of industrial and production activities. It is possible to establish enterprises of five hazard classes. An additional advantage is the proximity to the markets of shipbuilding and the oil and gas industry - oil and gas companies are implementing their long-term projects in the Astrakhan region and on the shelf of the Caspian Sea; large and medium-sized shipbuilding

enterprises (including divisions of the United Shipbuilding Corporation) operate in the region.

Considering the political and economic situations, the most promising industries for arranging production on the territory of SEZ Lotus are shipbuilding, production of equipment and components for oil and gas industry, chemical industry, food processing industry, pharmaceutical and other high-technology industries. The industries are determined on the basis of considerable level of recourses in the Astrakhan region and in the Southern Federal District. JSC SEZ Lotus provides the tenants with the needed amount of such resources as water, gas, electricity.

A tenant of a port SEZ may carry out the following port activities:

- goods warehousing, storage and other service typically rendered in a port;
- provision and equipment of vessels;
- production, repair, maintenance, modernization of sea-going, river vessels and other components;
- water biological resources processing;
- preparation operations of goods for sale and transportation (packing, sorting, repacking, lot dividing, marking and similar operations);
- simple assembly and other operations, execution of which does not considerably change goods condition according to the list approved by the Russian Federation Government;
- exchange trade in goods;
- wholesale trade in goods;
- provision of port special economic zone infrastructure object functioning;
- production activity according to the port special economic zone activity agreement.

Tenants of special economic zones would have the following preferences:

- tax and customs concessions (according to the laws of the Russian Federation);
- free connection to utility infrastructure;
- a “one-stop shop” system breaking administrative barriers in business operations;
- powerful logistic capabilities (rail, road and ship transport);
- preferential land lease terms, possibility to buy a land plot upon completing the construction of the real estate item on the land plot.

The project of an industrial production special economic zone tenant should provide at least 120 million rubles investment in his own production and this amount contains such expenses as construction of industrial facilities, equipment costs and other operating expenses necessary for commencement of works. The project of a port special economic zone tenant should provide at least 400 million rubles investment for the construction of the port infrastructure and at least 120 million rubles for the reconstruction of the port infrastructure.

To obtain a tenant status, a business plan must be developed. After a successful presentation of the business plan the company concludes an agreement on industrial production activity with the Government of the Astrakhan region and JSC SEZ Lotus. Within three years of the date of conclusion of the agreement on carrying out activity a tenant is obliged to make capital investments in the amount not less than of forty million rubles. 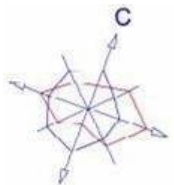
